opportunity to meet your neighbors and show support of their local police departments in the fight
against crime. Along with several Plano Police Officers, we expect Mayor, John Muns, and Police

Chief, Ed Drain, to join us at NNO as they did last year. So come on out to Prairie Meadow Park on
Tuesday, October 4 at 6:00 PM. We will have Handel's ice cream, and you will have the opportunity

to meet fellow Whiffletree and EFC neighbors along with City of Plano Leadership and many of the Plano Police Officers who protect us and our property. Hope to see you there.

Plano ISD is holding a bond election on November 8. The items on the ballot include Proposition A for Voter Approved Tax Rate Election (VARTE), which is required by the State of Texas that asks voters to consider approving a modified tax rate to increase revenues for student programs and teacher & staff salaries. On September 10 at the Plano Police Substation on Independence, Plano Police Officer Sheldon Krc, from Crime Prevention Unit, presented a seminar titled, Civilian Response to Active Shooter Event. In addition to reviewing statistics and some of the causes behind people taking such terrible actions, Officer Krc also reviewed what we as citizens can do if we find ourselves in an active shooter event. He described the 3 steps our brain goes through in such an event. They are:

- 1. Denial in other words, "this can't be happening".
- 2. Deliberation thinking about what we should do.
- 3. Decisive Action making a decision and taking action to protect yourself

The decisive actions include:

- 1. Flight run as far away from the event as you need to feel safe and then call 911 to report the event. Officer Krc emphasized that your first priority is to get as far away from the event to feel safe, then and only then call 911.
- 2. Hide ideally in a room where you can lock the door and barricade the entrance until the police arrive.
- 3. Fight as a last resort if no other option. Officer Krc made the point that if you fight, do not fight fair. Do whatever you have to do and use whatever is available around you to protect yourself. If there are others with you, team-up and fight as a unit. Work together to overwhelm your enemy.

Officer Krc pointed out that getting from Denial to Decisive Action needs to be a rapid process. He said that in active shooter events, seconds matter. He also stated that if you encounter police arriving at the scene, make sure you show your palms to police officer(s) so that they know you are not the shooter or a danger to them, and follow their instructions. Finally, Officer Krc stated that the majority of active shooter events occur inside buildings, commercial establishments, schools, churches, etc. He said that when you enter a building, make a mental note of alternative exits, much like we do when going through the safety presentation on an airplane to look for nearby exits. It is most likely that

the main entrance/exit is where the shooter enters the building and may not be a viable exit point. He stated just a casual look around the building to identify alternate exits may help you get to the Decisive Action quickly and exit the building safely. It is just a matter of being aware of your surroundings and ready if such a horrific event happens.

Officer Krc showed a video of an enactment of an active shooter event. This video is not gory. It does highlight some of the actions to be taken in an active shooter event. You can see this video at https://youtu.be/TeOdxKozra0
